1. Parents/Guardians. Parents/Guardians agree that student shall be enrolled in the program for the fall semester of 2019, which begins on Monday, August 19, 2019 and ends on Thursday, December 12, 2019.
 2. Non-refundable Fees and Deposits. Parents/Guardians agree to pay to Freedom MMO the following non-refundable fees and deposits:
 - a. Registration Fee. For new and re-enrolling students, Parents/Guardians agree to pay a \$30 non-refundable semester registration fee per child. Payment of the registration fee is due at the time this enrollment contract is received by Freedom MMO.
 3. Tuition Payment Options.
 - a. Monthly Payments. Monthly payments are due the student's 1st school day of each month. Late payment will result in a late fee of \$25.00.
 - b. One-Time semester payment.
 4. Freedom MMO's termination/early withdraw of enrollment contract.
 - a. Return of Fees and Deposits. Parents or guardians agree and understand that the registration fee is non-refundable.
 - b. Termination. All students will be accepted on a conditional basis. Parents or guardians may be asked to withdraw student if Freedom MMO determines that the program is not meeting student's needs or that the student's presence is having an adverse effect on the program. Parents or Guardians agree and understand that termination of this enrollment contract and un-enrollment of the student from Freedom MMO's program does not change the refund provisions set forth in this enrollment contract.
 - c. Early Withdrawal from the program must have a 30 day written letter. Parents and guardians understand and agree that tuition will be paid in full during the 30 day withdrawal period.

 - a. There is a 10 minute grace period to pick up your child(ren). Once the time is 1:10 P.M., you will be charged a fee of **\$5 per minute per child**. The fees will be automatically charged to your form of payment on file. **Initials:** _____
 - b. Illnesses and Vacations: Freedom MMO does not give refunds for days student is absent due to illnesses, vacations or other personal reasons.

c. School Closure: Freedom MMO will follow weather closings based on the National Weather Service and Government Executive Orders. In the event of closure beyond control of Freedom MMO, refunds will not be given.

d. Please note the BCSD Calendar for a schedule of days the school will be closed.

e. Any declined charges will require a \$35.00 reprocessing fee.

f. Freedom MMO reserves the right to adopt/amend rules and regulations as deemed necessary. The Student and the Parents or Guardians shall comply fully with the rules and regulations as stated or amended in this contract.

g. Disciplinary Policies and Procedures

STEP 1. Verbal warning and written documentation. Original copy will be kept on file and a copy will be given to parent(s).

STEP 2. Written Warning along with meeting between Teacher/Parent/Director for plan of action on how to help the student succeed. Information may be given at this time to the parent on how to help coach the student at home.

STEP 3. After a third write up for behavior, the Director may deem necessary for the student to be withdrawn from the MMO program. Please refer to Section 4(b) for further details.
